**HealthSpace develops and provides sophisticated information management system for the surveillance, business management, compliance and tracking of regulatory and quality control applications. Clients include government regulatory agencies and private sector businesses who require collected data along with auditing applications for the purpose of improving productivity, quality control and performance analysis.**

**HealthSpace’s ongoing engagement with government customers in both the US and Canada continues to drive growth and viable learning opportunities to continue to innovate our technology offerings. In 2019, we are continuing to actively introduce our platform and services into commercial enterprise clients in food & beverage, hospitality, assisted living, and child-care. Ongoing discovery work based on HealthSpace’s agricultural capabilities is now being integrated into cannabis production and distribution processes through work with both US and Canadian partners.**

**HealthSpace has developed several relationships within the cannabis space and has begun detailing some product changes in order to cultivate market traction. The Company is exploring opportunities with multiple regulatory agencies that oversee and regulate cannabis producers. The Company intends on leveraging its vast experience in developing SaaS platforms for enforcement and compliance into the cannabis space where there is little in the way of software offerings that adequately handle compliance.**

- **On February 11, 2019, the Company announced that it entered into a Memorandum of Understanding (MoU) with the Tennessee Department of Health (the "Department" or "Tennessee") to pilot the initial launch of the My Health Department platform. Once development is completed, this arrangement allows for business owners across the entire state to register an account on the platform in order to track their business' information and pay for all fees issued by the Department.**

**The My Health Department platform will be a useful resource for businesses to effectively address regulatory and permitting issues. Business owners, especially those with multiple outlets, have for years experienced frustration with not being able to efficiently track inspection data on all of their locations. The My Health Department platform also will provide owners with more payment options, such as making online payments for all of their locations in one simple process.**

**In addition to signing on Tennessee, HealthSpace has entered into an agreement with a Fortune 500 payments provider to integrate their products and features into the My Health Department platform. This arrangement provides HealthSpace the ability to share in the revenue that comes from online payments, thus, adding an additional line of revenue for the Company. Further, working with one of the world's largest providers of online payments means these tools will be streamlined providing significant value-add to both government agencies and private businesses.**

**My Health Department platform will change the way businesses look at and interact with regulatory data collected by environmental health departments. In providing simple, free-to-use tools and features, businesses can have a better handle on how to approach regulatory issues. By launching this pilot, HealthSpace is creating a marketplace that sets up a direct relationship with individual businesses across the country to be able to provide additional products and services in the future, while simultaneously creating more accretive revenue streams.**
